I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws Rules and Regulations, and duty to arbitrate, all as from time to time amended. Finally, I consent that and authorize the Association, through its membership committee or otherwise, to invite and receive information and comment about me from any member or other person and I agree that any information and comment furnished to the Association by any member or other person in response to any invitation shall be conclusively deemed to be privileged and not from the basis of any action by me for slander, libel, or defamation of character. NOTE: Applicant acknowledges that the association will maintain a membership file of information which may be shared with other boards/associations where applicant subsequently seeks membership. This file shall include: previous applications for membership; all final findings of Code of Ethics violations of other membership duties within the past three (3) years; pending complaints alleging violations of the Code Of Ethics or alleging violations of other membership duties; incomplete or pending disciplinary measures; pending arbitration requests; and information related to unpaid arbitration awards or unpaid financial obligation to the board/association or its MLS.

NOTE: Applicant acknowledges that if accepted as a member and he/she subsequently resigns from the board or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a member.

#### 5. ADDENDUM TO APPLICATION FOR MEMBERSHIP

I hereby certify that I have read the following provisions contained in the judgment of the United States District Court for the District of Arizona in Action No. CIV 73-559 PHX.WEC:

##### **ADDENDUM V**

Each of the defendant Boards/Associations, whether acting unilaterally or in concert or agreement with any other person, and each of the remaining defendants when acting in concert with third persons, with respect to transactions involving residential real estate, is enjoined and restrained from:

- A. Fixing, establishing or maintaining any rates of amounts of commission or other fees;
- B. Urging, recommending or suggesting that any of its members adhere to any rates or amount of commission or other fees;
- C. Adopting, suggesting, publishing or distributing any schedule or other recommendation concerning the rates or amounts of commissions or other fees;
- D. Adopting, adhering to, maintaining, enforcing or claiming any rights under any by-law, rule, regulation, plan or program which restricts or limits the right of any person engaged in residential real estate to agree with his/her client on any rates or amounts of commissions or other fees in accordance with his/her own sound business judgment;
- E. Taking any punitive action against any person where such action is based upon the person's failure or refusal to adhere to any schedule or other recommendations concerning rates or amounts of commissions or other fees;
- F. Refusing to accept for multiple listing any listing for the sale of residential real estate because of the rate or amount of commission set forth in such listing;
- G. Considering in any way the commissions charged by any person duly licensed as a real estate broker in passing upon the application of such person for MLS participation in any Board/ Association of Multiple Listing Service.

##### **ADDENDUM VI**

Each defendant is ordered and directed within ninety (90) days from the date of entry of this Judgment to insert in all listing agreements, used by, distributed to or made available to or by any defendant, in connection with the sale of residential real estate, which will require a client's signature and in which rates of amounts of commissions or other fees will be specified by the parties, a provision prominently situated in all capital letters substantially as follows:

**"THE COMMISSIONS PAYABLE FOR THE SALE, LEASE OR MANAGEMENT OF PROPERTY ARE NOT SET BY ANY BOARD/ASSOCIATION OF REALTORS® OR MULTIPLE LISTING SERVICE OR IN ANY MANNER OTHER THAN BETWEEN THE BROKER AND THE CLIENT"**

Applicant acknowledges that if accepted as a member and he/she subsequently resigns or is expelled from MLS participation in the Association with an Ethics complaint or Arbitration request pending, the Board of Directors may condition renewal of MLS participation upon applicant's verification that he/she will submit to the pending ethics or arbitration proceeding and will abide by the decision of the hearing panel; or if applicant resigns or is expelled from MLS participation without having complied with an award in arbitration, the Board of Directors may condition renewal of MLS participation upon his/her payment of the Award, plus any costs that have previously been established as due and payable in relation thereto provided that the award and such costs have not, in the interim, been otherwise satisfied.
